

Syllabus and Course Regulations

Course Outline

The paper on Child Rights & CSR will be offered at the Madras School of Social Work, between September and December 2016 over roughly 30 hours. It aims to introduce students to the concept of Child Rights, expose and sensitize them to a broad range of issues affecting children in South Asia, with a specific emphasis on India, and help them understand how to CSR can address the children's issues responsibly and effectively. The course will be delivered in four units.

Unit - 1: HUMAN RIGHTS AND CHILD RIGHTS

(5 Hours)

1.1. Introduction to Human rights:

Meaning, Definition and Concept of Human Rights – Difference between Natural Rights and Human Rights – The Universal Declaration of Human Rights – The Indian Perspective – Defending Human Rights – Efforts by the State, NGOs and Civil Societies

1.2. Introduction to Child Rights

History and Evolution of Child Rights – Need and Importance Child Rights – The notion of the child as a potential individual – United Nations Convention on the Rights of the Child (UNCRC) – Committee on Rights of the Child – Sensitivity to the responsibility of stakeholders, i.e. all adults

1.3. Barriers to the Realization of Child Rights

Protecting human rights – Upholding children's rights – Problems in realizing children's rights – Responding to the challenges of children's rights – Sensitivity towards culture and cultural differences

Note: Child Rights must not be linked to violations alone, and the elective shall therefore focus on the positive dimensions as well.

Unit - 2: MAJOR ISSUES AFFECTING CHILDREN AND LEGISLATIONS

(10 Hours)

2.1. Overview

Various Dimensions of Child Rights, Issues Plaguing Children the World over, Exploitation and Deprivation Children face. The policy angles, Children's issues in Connection with the socioeconomic, political and cultural factors from which they cannot be isolated.

2.2. Demographics

Population of children in various parts of the country, their distribution – Sex ratios – Child Mortality, Infant Mortality, Maternal Mortality Rates – Areas with the worst human development indicators – Social Exclusion – Children from marginalized, backward communities – Sources of Data

2.3. Child Labor and Access to Education

Child labor as a function of extreme poverty and lack of adequate livelihoods – Poor access to education – Enrollment rates and drop-out rates – Gender differentials – Quality of Education – Right to Education

2.4. Health

Malnutrition, its causes and consequences – HIV AIDS, common diseases, illnesses – Unequal access to adequate and effective health care, poor infrastructure – Low immunization rates – Access to drinking water and sanitation facilities – Menstrual hygiene management – Fostering positive mental health.

2.5. Child Abuse and Violence against Children

Sexual abuse, trafficking, prostitution, incestual abuse — Abuse by omission- neglect, abandonment — Street children, orphans and children in institutions — Children displaced by calamity, conflict or migration — Corporal punishment — Cultural practices that are abusive to children — Dispelling myths about child abuse
