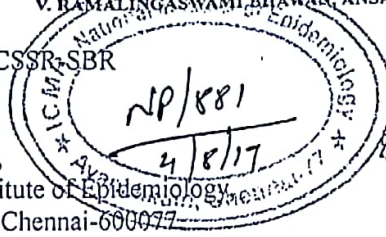



The Grant-in-Aid will be given subject to the following conditions:

1. The payment of the grant will be made in lump sum to the Head of the Institute. The installment of the grant will be paid generally as soon as the Council receives report regarding the commencement of the project and appointment of the staff. The demand for the payment of the subsequent installment of the grant should be placed with the council in prescribed Performa attached.
2. The staff appointed on the project should be paid as indicated in the budget statement attached.
3. The approved duration of the research scheme is **2 Years**. The annual extension will be give after review of the work done on the research scheme during the previous year.
4. Ten copies of the annual progress report of work done be submitted to the council after completion of One year of the project.

5. The institute will maintain a separate account of the receipts and the expenditure incurred on the research scheme and will furnish a utilization certificate and an audited statement of the account pertaining to the grand.
