A Situational Analysis

Terms of Reference

Brief background:

Kannagi Nagar and Ezhil Nagar are slum re-settlement areas located in Chennai, built by Tamil Nadu Slum Clearance Board (TNSCB) for rehabilitating displaced people between 2000 and 2010. Kannagi Nagar has 15,656 tenements and approximately 78,280 populations. Ezhil Nagar comprises 8,048 tenements with a population of about 40,240. The combined population of the two settlements is 1,18,520 living in 23,704 households. Residents of these tenements live in cramped spaces with the bare minimum amenities.

The poor health status of women in India is mainly due to patriarchy and other socio-cultural constraints leading to her secondary status at home and poor health. It is a bitter reality that in India women's health and nutrition is inextricably linked to social, cultural, and economic factors.¹

Anaemia is a major health problem in Tamilnadu, especially among women and children. According to the National Family Health Survey (NFHS 4) 55% of women in Tamil Nadu have anaemia, including 40 percent with mild anaemia, 14 percent with moderate anaemia, and 1 percent with severe anaemia. Among children between the ages of 6 and 59 months, 50 percent are anaemic.²

Nutritional problems like protein energy malnutrition, iron deficiency anaemia, Vitamin A deficiency, iodine deficiency disorders continue to threaten a large proportion of children in India. Malnutrition reflects an imbalance of both macro and micronutrients that may be due to inappropriate intake or inefficient biological utilization due to the internal and external environment. The nutritional status and diet of children residing in slums is very unsatisfactory³.

Through our COVID 19 Slum intervention program in Kannagi nagar and Ezhil nagar slum resettlement areas, we learned that nutrition problems anchored with anaemia seems to be common and we would like to understand the severity of the same

Hence, in this regard, VHS under the COVID 19 Slum Intervention Project, proposes to engage a consultant for conducting a situation analysis in Understanding malnutrition among women and girls of reproductive ages in Kannagi nagar and Ezhil Nagar.

<u>Terms of Reference (ToR)</u>: The Consultant will be responsible for situation analysis in Understanding malnutrition among women and girls of reproductive ages in Kannagi nagar and Ezhil Nagar.

The major scope and coverage of the feasibility assessment includes:

- Recommend nutritional interventions to address malnutrition

- Make a presentation on the proposed broad approaches to conduct the assessment
- Incorporate the inputs received by the project team in terms of conducting the assessment
