Memorandum of Understanding Between Madras School of Social Work AND Thuvakkam Thisagreement is made on this day 26thJanuary 2020

BETWEEN

MADRAS SCHOOL OF SOCIAL WORK (MSSW), established in 1952, located in Chennai, South India, is an Autonomous Institution, NAAC accredited and affiliated to University of Madras. Madras School of Social Work was founded by Mary Clubwala Jadhav under the auspices of Madras State Branch of the Indian Conference of Social Work (renamed the Indian Council of Social Welfare) and the Guild of Service (central). The school is run under the aegis of the Society for Social Education and Research (SSER). The School is rated 3rd Best Social Work College in India and First in South India.

MSSW is established with a vision to be a global leader in education, research and intervention in social work and allied disciplines towards transforming the human potential into socially sensitive change agents for sustainable development and to create outstanding professionals, who will provide transformational leadership in the community and workplace.

AND

THUVAKKAM WELFARE ASSOCIATION (SI.NO:131/2014) a registered NGO under Section 10 of the Tamil Nadu Act, 1975 (TAMIL NADU ACT 27 OF 1975)India, having its Office at 27/5,AdamStreet,Mylapore,Chennai-600004,Tamil Nadu, India. (hereinafter referred as "THUVAKKAM")

Thuvakkam is a non-governmental organization working towards the betterment of society. Thuvakkam, which implies a beginning in Tamil commenced with a vision; "To create a better society while upholding its virtues." The main ideology followed by the team is to generate awareness on social issues while promoting a sustainable environment thereby paving way towards societal developments in our surroundings. Over the years, the team has grown exponentially and have become influential in various domains; especially in the fields of environment and education. Thuvakkam is currently working on a total of 7 sustainable initiatives (Pasumai Thuvakkam, Clean- Up After dark, Karkakasadara, Modern Thandora, ManninMainthargal, Kural -The Voice of truth and Urban Forestry). Each initiativefocusses on building a better environment and society by re-kindling the humanity among the people involved.

The following activities will be jointly planned and executed between MSSW-Thuvakkam:

- Jointly develop projects, raise funds, participate in bidding and implement jointly or subcontract or work part of a consortium with other development agencies or private companies complimenting with their respective strengths with scope for Environment and Education related projects.
- Thuvakkam and MSSW jointly do research on Particular areas in our society and based on their results will jointly work to find and implement solutions.
- Thuvakkam and MSSW will jointly work on relief works during any natural disaster situations.
- 4. Thuvakkam will provide internships and field visits for MSSW students in all their projects.
- Organize seminars/workshops on Environment studies, Social Work, Community entrepreneurship and social entrepreneurship.
- 6. Thuvakkam will teach and give opportunity to interested MSSW students to explore various areas of day to day operations of our Organization and implement their skills in areas like Event management, Public Relation, Volunteer engagement, Corporate Relationships, Sponsorship and Social Media Marketing.
- 7. Thuvakkam will Provide their online platform to MSSW Students to express their talents like Writing, Photography, Video Editing, Poster making, Art worketc. Also, will guide them the positive way to use those betterment of our society.

Duration

This MoU will be effective from the date of signing by both parties up to a period of 5 years and may be subject to extension by mutual consent of the parties in writing. The provisions of this MoU may be amended any time with mutual consent of the parties in writing.

Termination

Either party may terminate the agreement by giving 6 (six) months advance notice in writing. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the two parties.

Each party will take approval from the other party in writing to use the later's name and logo for the activities hereunder on case to case basis and the other party will provide a reply at the earliest or maximum within 7 days in writing.

Jurisdiction

The MoU shall be governed by and constructed according to Laws in force in India. The parties hereby submit to the exclusive jurisdiction of the courts situated in Chennai for all purposes.

Arbitration

In case of any dispute or difference arising out of the MoU, which cannot be resolved mutually between two parties, it shall be referred to two arbitrators to be appointed by both parties in the proportion of one each. After hearing both parties the arbitrators will give reasoned and speaking award, which shall be binding on both parties. The venue of arbitration shall be Chennai, India.

Force Majeure

Neither party will be liable to the other for nonperformance of this MoU or any part thereof due to Force Majeure conditions, such as Acts of Gods, fire, floods, earthquakes, explosions, acts of sabotage, or terrorism, war, riots and any other circumstance (natural) beyond the control of the party.

Notices

Any notices to be given under this MoU shall be in writing and shall be deemed to have been duly and properly served upon the parties hitherto if delivered against acknowledgement of by registered mail addressed to the parties herein at the addresses given at the initial paragraphs of this MoU or such changed address duly notified by the parties.
