Within 14 days of signing the scholarship grant agreement, the participant will transfer a **225 Euro** security deposit to the account of the Foerderkreis Braille Ohne Grenzen- kanthari e.V. in Germany. This caution deposit is a security amount for any possible damage to kanthari's property and/or equipment caused by participant and/or to cover any other emergency costs.
12. Grantee's personal expenses, including items for personal hygiene, telephone calls etc. For this purpose, Grantee should have with him/her approximately US\$ 400 to US\$ 500.

BWB-kanthari does not guarantee participation in the program if the applicant is not able to raise sufficient funds to cover the above listed expenses.

You may use this admission letter for fundraising purposes to raise the necessary amount to cover the above-mentioned costs.

In case the caution deposit is not received within 14 days of the date of which the Scholarship grant agreement has been signed, the same agreement will be cancelled.
